# Electronic Recording of Classes by Students

The AFC also dealt with the question of the electronic recording of classes by students. We were advised by CAUT that this has emerged as a problem in the United States, where teachers have found portions of the classes posted on YouTube without their permission. The AFC devised the following statement for inclusion in course outlines:

"Electronic recording of classes is expressly forbidden without prior consent of the instructor. When recordings are permitted they are solely for the use of the authorized student and may not be reproduced, or transmitted to others, without the express written consent of the instructor."
